Handling: Supply with sufficient partial air exhaust.The operating staff Must have received special training and abide by the operating regulations,It is advised that the staff wear respirator,wear work clothes,and wear gloves.Keep away from the fire source,heat source,no smoking in the work place.

Avoid producing dust.Use explosion-proof type ventilation system and device.

Avoid contacting with oxidizer and strong acid .Equip with relevant types and quantities of extinguish instruments and device for divulge handling.Empty the container which may include harmful material.

Storage: Keep the sample in the cool and well-ventilated place.Keep away from fire and heating sources.Keep separately from oxidizer and strong acid,no mixing storage.Equip with relevant types and quantities of the extinguish instruments.The storage place should be equipped with suitable shelter material for divulge handling.
